IMPORTANT UPDATES

BENEFICIAL OWNERSHIP INFORMATION (BOI) REPORTING – URGENT

In December, BOI reporting was ruled unconstitutional. However, a recent ruling has [reinstated](#) the requirement, meaning all businesses must [file a BOI report](#).

DON'T WAIT! Non-compliance penalties are **\$500 per day**. If you need assistance, we're here to help!

Updated as of Feb. 19, 2025: Beneficial ownership reporting requirements are back in effect, with a new deadline of [March 21, 2025](#), for most companies. FinCEN may further modify deadlines. Learn more here: [FinCEN BOI Notice](#).

UPCOMING TAX DEADLINES

CORPORATE & PARTNERSHIP TAX RETURNS – DUE MARCH 15, 2025

- All [corporate and partnership tax returns](#) must be filed by **March 15, 2025**.
- If you need more time, an [extension](#) can be filed, granting an additional **six months** to complete your return.

INDIVIDUAL TAX RETURNS – DUE APRIL 15, 2025

- **Tax season is moving fast!** If you haven't filed your taxes yet, now is the time to [gather your documents and bookkeeping records](#).
- If you need extra time, you can [file for an extension](#), but remember—an extension [only extends the filing deadline, not the payment deadline](#).
- To [avoid penalties and interest](#), estimate and pay any taxes owed by **April 15, 2025**.
- An extension will move your filing deadline to **October 15, 2025**. If you need help filing an extension, reach out!



FLORIDA SALES TAX REMINDER

FOR OUR FLORIDA-BASED CLIENTS:

- Florida sales tax payments are due by the 20th of each month for the previous month's sales.
