BENEFICIAL OWNERSHIP INFORMATION (BOI) REPORTING

A key update from the Corporate Transparency Act: The Beneficial Ownership Information (BOI) reporting requirement took effect on January 1, 2024. If your business was established before 2024, you must submit your BOI report to the Financial Crimes Enforcement Network (FinCEN) by **December 31, 2024**. Missing this deadline could result in penalties of \$591 per day starting January 2025. If you need assistance with your BOI filing, we're here to help.
